
I am directed to inform that, the competent authority has approved Unfreezing of **LMCS Upscaled 2013 scheme for the following ongoing clusters only** when the scheme was frozen on 13 August, 2019 which meet the criteria of the timeframe as per the scheme guidelines i.e. The clusters need to achieve all 5 stages within 18 months (plus 6 months after PMAC approval).
