

Brief Industrial Profile of Purnea District

1. General Characteristics of the District

Purnia district is one of the thirty-eight districts of Bihar state, India. The town of this district, Purnia district is a part of Purnia Division. The district extends from the Ganges River northwards to the frontier of Nepal. It is one of the 38 districts in Bihar, currently receiving funds from the Backward Regions Grant Fund Programme (BRGF). Agricultural products include: Paddy, Maize, Pulses and Wheat and also Oil Seeds. Roughly one third of the area sown is under rice (Paddy). Cash crops such as vegetables and water-melons are also grown.

1.1 Location & Geographical Area

Purnia district is situated in Northern part of Bihar. It is surrounded by Araria and Kishanganj district in north, Katihar district in south, West Bengal in east and Saharsha and Madhepura district in west. The geographical area of the district is 3229 Square Kilometer.

1.2 Topography

Purnea has an area of 3229 sq km. it is a level, depressed tract of country, consisting for the most part of rich, loamy soil of alluvial formation. It is traversed by several rivers flowing from the Himalayas, which afford great advantages of irrigation and water-carriage. Its major rivers are the Kosi, the Mahananda, the Suwara Kali and the Koli. In the west the soil is thickly covered with sand deposited by changes in the course of the Kosi. Among other rivers are the mahananda and the panar. Height above Sea level is 171.2 Feet. Normal Rainfall is 1470.4 mm and average number of rainy days is 73. Average temperature is 28°C with maximum and minimum being 48°C and 03°C respectively.

1.3 Climatic Conditions

The district generally has a most humid climate. The winter season starts from November to February and January is the coldest month with the mean minimum temperature below 9°C and the summer season starts from March and lasts till mid June. The maximum temperature reaches up to 44°C. The monsoon season begins in early June and lasts until September and maximum annual rainfall falls during the monsoon season. Wind is typically light in the non-monsoon seasons but during the monsoon, storms and depressions originating in the Bay of Bengal cause heavy rain and strong winds.

1.4 Availability of Minerals:

The geological formation of the district consists almost entirely of alluvium and there are no minerals of any importance in the district.

1.5 Forest

The district of Purnea has an area of 562 hectare under forest coverage. The monsoon and prairie forest is available in the district. The Principle trees are Sal, Sakhua, Teak, Shisham, Palas, Peeple and Semal.

1.6 Electricity and Power

There is no electric power house located in this district. The district gets electricity from Thermal Power Stations located outside the district. In the rural areas, the Government is trying to extended electric line to the maximum number of villages by implementing various schemes for rural electrification. 486 villages are electrified in the district of Purnea.

1.7 Administrative set up

Administrative Head of Purnia is District Magistrate. Other senior official of the district, subdivisions and blocks coordinate with the district administration. Purnea district has 4

sub-divisions. Purnea banmankhi kashba and Dhamdaha and they are further composed of 14 blocks namely East Purnia, Krityanand nagar, Banmankhi, Kaswa, Amaur, Bainsi, Baisa, Dhamdaha, Barhara Kothi, Rupauli, Bhawanipur, Dagarua, Jalagarh and Srinagar.
