

Nomination of officer for above with following terms & conditions:-

- a. The deployment of the official is tentatively for 04 months or until further orders, whichever is earlier.
- b. The officers will report to the GMs/PDs of the concerned mentor TCs for this period.
- c. The official will support in commencing the Training from 01/11/2018 and also support in establishing the concerned new Technology Centre.
- d. The officers will continue to draw the salary from concerned MSME DI/ Br. MSME DI.
- e. The expenditure on TA/DA of the officers deployed at TC will be borne under TCSP. The entire duration of the officers' stay outside their original Hqrs. ( i.e. in all cases except for those at Sl. No. 7,8 and 10 ) will be treated as Tour on duty and, for this period they would be entitled to all allowances as admissible when they are on such tours.
- f. The officers should be available at the earliest at their new places of duty. The concerned DI/Br.DI should release these officers latest by 14-09-2018 for their duties.
- g. For the officers mentioned above, the APARS for their periods of duty outstation would be written by the GMs/PDs of the concerned Mentor TCs.
