

**Minutes of the 3rd meeting of Technical Committee of Digital MSME scheme
held on 13.06.2017 at 03.00 P.M. in O/o DC(MSME)**

3rd meeting of the Technical Committee (TC) as constituted in the new "Digital MSME" scheme was held on 13.06.2017 under the Chairmanship of Shri Piyush Srivastava, Additional Development Commissioner, O/o DC (MSME). List of participants is enclosed.

2. During the meeting, following issues were discussed and decisions taken:
- (i) As decided in 2nd meeting of TC, TCIL was to finalize service providers in 4 verticals and present the services in matrix form so as to be considered by TC during its 3rd meeting. In response, TCIL submitted details of only 1 vertical i.e. ERP as the prospect received pertained to this vertical only. Under the ERP vertical, 7 service providers have offered various modules and quoted market rate as well as price offered under Digital MSME scheme. TC observed that rates offered under Digital MSME scheme are economical as compared to market rates, hence, accepted the offers. Following 7 service providers were accordingly recommended to PMAC for providing ERP softwares as per rates offered:
 - (a) Syscon Solutions
 - (b) Eazy Biz Solution
 - (c) JILIT
 - (d) Konnect
 - (e) Blue Ocen System
 - (f) Influence Technolab
 - (g) Nippon Data
 - (ii) TCIL was asked to make efforts to engage service providers in remaining 3 verticals also (Accounting, Manufacturing/ Design and Regulatory Compliances including GST). TCIL was asked to submit the desired details in r/o remaining 3 verticals at the earliest possible which may be considered by TC during its next meeting.
 - (iii) TCIL was also asked to initiate necessary action regarding draft Service Level Agreement (SLA) to be signed between TCIL and service providers as per guidelines of the scheme.
 - (iv) As decided in 2nd meeting of TC, TCIL was requested to expedite the submission of schedule and time frame of each activity in r/o development of National Portal and other activities involved in implementation of the scheme.

Meeting ended with vote of thanks to the Chair.
