**Subject: Sanction of Rs.1,13,90,000/- (One crore Thirteen lakh and Ninety thousand only) as GIA-General to Central Tool Room & Training Centre (CTTC) Bhubneshwar for release to various implementing Agency (IA) to conduct Awareness Programme & National level workshops under Design – a sub component of MSME Innovative scheme during the FY 2022-23- reg.**

Sanction of the President of India is hereby conveyed to release of payment amounting to Rs.1,13,90,000/- (One crore Thirteen lakh and Ninety thousand only) as Grant-in-aid General for implementation of Design – a sub component of MSME Innovative Scheme, a component of MSME Champions under Technology Upgradation and Quality Certification (CLCS-TUS), to CTTC, Bhubneshwar as CNA for release to implementing Agencies for conducting 75 nos. of Awareness Programme and 6 nos. of National/ State level workshops approved in 2<sup>nd</sup> meeting of PMAC held on dt. 22.06.2022 for the FY 2022-23. (ii) ~~CTTC Bhubaneswar shall maintain separate subsidiary bank accounts for the Government Grants received and utilized. In addition, a separate Bank account shall be maintained for the Government Grants.~~

(iii) The Grant released will be utilized by CTTC Bhubaneswar by 31.03.2023 for the purpose indicated in para 2(i) above.

(iv) CTTC Bhubaneswar may furnish their performance-cum-achievement report on or before 31.03.2023 to the sanctioning Authority. (The bank account should be same which was authorized for operation at the time of registration under the 'Central Plan Scheme Monitoring System' (CPSMS) of the Ministry of Finance).

(v) CTTC Bhubaneswar should maintain a register of permanent and semi-permanent assets acquired wholly or mainly out of the above grant in the prescribed format and copy thereof should be furnished to this Ministry.

(vi) Assets acquired wholly or substantially out of Government Grant shall not be disposed of without obtaining the prior approval of the sanctioning authority of Grant-in-aid.

(vii) The accounts of CTTC Bhubaneswar shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG(DPC) Act, 1971 in accordance with the provisions laid down in Section 14 of the C&AG (DPC 1971) as amended from time to time and Internal Audit party of the Principal Accounts Office of the Ministry of MSME, whenever it is called upon to do so.

(viii) The grantee shall submit the Utilization Certificate in the prescribed form GFR-19A duly signed by the Head of the Institution/Grantee latest by 31.03.2023.

(ix) CTTC Bhubaneswar shall furnish an Audited Statement of Accounts of the financial year before 30.04.2023.

(x) Grant-in-Aid shall be utilized subject to the Economy and other Instructions issued from time to time by the M/o Finance or by the Competent Authority.

(xi) The unspent balances available with CTTC Bhubaneswar have been taken into account. There is no UC pending with CTTC, Bhubaneswar under MSME Innovative scheme.

(xii) CTTC Bhubaneswar shall certify that the utilization certificates due for submission for the Grants-in-aid sanctioned in the previous years containing all the relevant details under GFR 212(1) have been submitted to the satisfaction of the Minister (Ministry of MSME).

(xiii) CTTC Bhubaneswar should adhere to relevant provisions of GFR and any other instructions/guidelines issued by the Government from time to time while making procurement/purchases of goods and services including compliance to GFR provisions in case of out-sourcing of services and engagement of consultants.

(xv) CTTC Bhubaneswar shall, however, furnish an undertaking that it will comply with all the terms and condition stipulated in the sanction order.

(xvi) CTTC Bhubaneswar should send pre-receipted bill to this Ministry for payment of the amount drawn against this sanction.
