- Topics of E-SDP training program shall include both traditional (based on district potential including ODOP products) & other emerging topics like Digital Marketing, AI & ML, IOT, 3D Printing & program for hotel staff/ homestay owners, digital registration, tour guides, etc.
- Efforts should be made to select maximum possible number of participants from SC, ST, OBC, Women, PH, Ex-serviceman including Agniveer category.
- The funds are non-recurring in nature.
- The MSME-DFOs will keep separate account of utilization of these funds for each programme. The saving, if any, is NOT TRANSFERABLE.
- Advance sanctioned to a particular coordinating officer for a particular programme/activity shall be settled in a single bill, along with the programme expenditure bill as early as possible, latest within 15 working days of the conclusion of the programme/activity.
- Procurement of permanent assets from the programme sanction is not allowed.
