- Topics of E-SDP training program shall include both traditional (based on district potential including ODOP products) & other emerging topics like Digital Marketing, AI & ML, IOT, 3D Printing & program for hotel staff/ homestay owners , digital registration, tour guides, shop owners staff etc.
- Efforts should be made to select maximum possible number of participants from SC, ST, OBC, Women, PH, Ex-serviceman including Agniveer category.
- The funds are non-recurring in nature.
- The MSME-DFOs will keep separate account of utilization of these funds for each programme. The saving, if any, is NOT TRANSFERABLE.

8. Procurement of permanent assets from the programme sanction is not allowed.
9. Joint Director/HoOs, MSME-DFOs may use the fund for essential expenditure related to the training programme. The guidelines issued vide OM No. 01(01)/2021-22/SFC-SD dated 25.03.2022 must be followed. **The programmes must be completed in the FY 2024-25.**
10. The MSME-DFOs should follow the procedure prescribed under GFR and the various guidelines under the economy measures.
11. Joint Director/HoOs, MSME-DFOs will raise proposal for approval for commencement of programme and report completed numbers of training programmes in the monthly progress report of the same month in prescribed format on ESDP MIS Portal.
12. The Programmes should be conducted in collaboration of highly reputed institutes may be AICTE approved or any State or Central level Management Institute to leverage the best outcome of the training programmes.
13. The faculties for delivering lectures/sessions must be chosen on utmost diligence covering different spheres of training area.
14. The expenditures shall be accommodated in **Demand No. 68-** Ministry of Micro, Small and Medium Enterprises (MSME) for the year 2024-25 as follows in the table:
