Director/Joint Director should furnish the progress report of the work and also statement for actual expenditure incurred in consultation with CPWD authorities to this office by 10th of the following month inter alia with the reason or variation if any and ensure utilization of fund within the current FY 2026-27.
5. **Non spending of the sanctioned amount will be viewed seriously.**
6. Director/Joint Director shall furnish work completion certificate, Physical cum financial statement along with fund utilization certificate from CPWD to this office.

Director/Joint Director are requested to generate PFMS for their concerned CPWD and shall forward to the Principal Accounts Officer (Compilation) Ministry of Industry, Udyog Bhawan, New Delhi through concerned PAO, so as to enable the compilation office to generate Letter of Authorization to that concerned CPWD.
