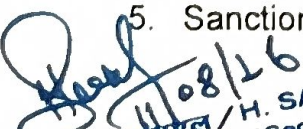

- This issues with the approval of AS&DC(MSME) vide e-office file no. 4020304, dated 10.08.2026.

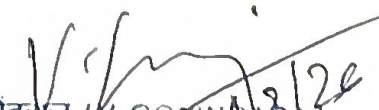
