# Subject: Settlement of Reimbursement Claims under Component 5(I)(A) of PMS Scheme – Regarding

Sanction orders worth approx. ₹30 crore have been issued in favour of around 4100 MSEs for trade fair participation during FY 2024–25, vide orders dated 11.04.2025 and 26.05.2025.

- 2. To ensure timely disbursal of claims of the MSEs mentioned in the aforementioned sanctions, the following actions are to be taken:
  - i. All MSME-DFOs shall complete reimbursement to MSEs by 20.06.2025, against the issued sanction
  - ii. DFOs shall update claim settlement status regularly on the Google Sheet shared by PMS Division.
- iii. Further, as per current data, for the FY 2024-25, **202** claims are pending at the DFO level, while **567** claims are pending with MSEs for want of clarifications sought by the respective DFOs (Annexure-A). Accordingly, DFOs are directed to immediately forward all pending claims for the FY 2024-25 to this Division.
- iv. Further, DFOs are directed to forward all claim request received from MSEs for fairs held during FY 2025–26 to this Division (Annexure B), at the earliest.
- 3. It is also informed that for claims pending with MSEs for FY 2024–25 in want of clarifications/necessary documents, an email is being issued to the concerned MSEs instructing them to submit the complete and updated claims to the concerned DFOs within 30 days. It is clearly stated in the said email that failure to do so will result in rejection of the claim without any further notice.
- 4. This issues with the approval of the competent authority.
