OFFICE MEMORANDUM

Subject: Submission of proposals by DFOs under Procurement and Marketing Support (PMS) Scheme for FY 2026-27 (upto 30.09.2026) – reg.

The undersigned is directed to refer to the subject mentioned above and to inform that the Department of Expenditure (DoE), vide OM dated 23.03.2026, has issued instructions regarding temporary continuation of schemes beyond 31.03.2026.

2. In this regard, it is informed that the proposal for temporary continuation of the Procurement and Marketing Support (PMS) Scheme upto 30.09.2026 or till approval of the restructured scheme for the 16th Finance Commission cycle (whichever is earlier) is under process with DoE, Ministry of Finance.

3. Pending approval of temporary continuation, all MSME-DFOs are requested to submit proposals of fairs/exhibition for the Financial Year 2026-27 (upto 30.09.2026) under the PMS Scheme and upload the same on the PMS Portal, for further consideration in this Office.

4. It is, however, clarified that approval of such proposals shall be subject to:
(i) Approval of temporary continuation of the PMS Scheme by DoE;
(ii) Compliance with PMS Scheme Guidelines and examination of the other relevant factors during consideration of the proposal; and
(iii) Directions, if any, received from Ministry of Finance or Budget/IFW of Ministry of MSME.

5. Further, as informed by DoE vide its OM referred above, such temporary extension of the existing scheme shall have the same scope, structure, nature, coverage, cost norms, and other terms & conditions as was applicable for the 15th FC period.

6. This issues with the approval of the competent authority.
