OFFICE MEMORANDUM

Subject: Clearance of Pending Reimbursement Amount under Component 5(I)(A) of PMS Scheme

This is with reference to the financial sanctions issued under Component 5(I)(A) of the PMS Scheme towards reimbursement to Micro and Small Enterprises (MSEs) participating in domestic trade fairs/exhibitions under Component 5(I)A of the PMS Scheme.

2. As per records, this Division has issued three sanctions amounting to ₹30.06 crore till May 2025. Out of this, Approx. ₹18 crore has been reimbursed by various DFOs, and reimbursement proposals amounting to approximately ₹4.79 crore are under submission to PAO. **However, approximately ₹7.25 crore is still pending with some of the DFOs.**
3. During the meeting held in June, 2025 and subsequent communications, it was specifically requested that all reimbursements for sanctions issued till May, 2025 be completed by 15.07.2025. However, significant pendency still remains.
4. In view of the above, all DFOs with pending amounts (as per the enclosed list) are once again requested to clear the reimbursement of the sanctioned amount to MSEs latest **by 25.07.2025**, without any shortfall.
5. This may be treated as urgent and necessary action may kindly be taken accordingly.
