Brief Industrial Profile of Shimla District

1. General Characteristics of the District

Shimla district is a totally hilly district of Himachal Pradesh. This district became part of Himachal Pradesh on 1st November, 1966 after the reorganization of Punjab state. It came into its present form on 1st September, 1972 when district Mahasu and Shimla were reorganized. The headquarter of this district is at Shimla which once used to be the summer capital of Britishers. As per population census of 2011, the total population of this hilly district is 8,13,384. The people of this district are innocent, honest and peace loving.

Agriculture and horticulture are the prime economic activities of this district. Most of the area under agriculture in the district is rain fed. The productivity for most of the agriculture crops is low because of the small size of holdings and rough terrain. However during the last few years, poly houses are being set up in the rural areas growing vegetables and flowers which has increased the economic condition of the inhabitants of this district to some extent. Horticulture has proved to be a major source of cash crop in the district. The district has given a pride place to the state of Himachal Pradesh in the production of apples as a result of which the state is known as the "Apple State of India". Tourism industry has also developed substantially in the district because of the topography and scenic beauty it contains. Places like Shimla, Kufri, Narkanda, Naldehra, Fagu, Tatapani etc. attract a large number of tourists to this district creating huge market for developing hotels, restaurants, cyber café, handicrafts items etc. in the district.

1.1 Location & Geographical Area.

Shimla district is situated in the south east of Himachal Pradesh. It is bordered by district Kullu in the north, district Kinnaur in the north east, district Sirmour in the south, district, district Dehradun of Utranchal in the east, district Solan in the west and district Mandi in the north west. The total geographical area of the district si 5131 Sq. Kms. which constitute 9.2% of the total geographical area of the state.

1.2 Topography

The topography of the district is entirely hilly. The altitude of the district ranges from 600 meters at Tata Pani to 5760 meters at Gushu Pishu in Pandrabis area. The district has many mountains and deep ravines. Sutluj is the biggest river of the district. The other rivers in the district are Tons, Pabbar and Giri Ganga.

1.3 Availability of Minerals.

District Shimla is not having any major mineral. Sand and Building stone are the two minor minerals which are being commercially exploited in the district. These minerals

are used in construction activities in the district. The details of these minor minerals is given below.

1.4 FOREST

Forest plays an important role in the economy of the district. Forest occupies an area of 1,30,411 hectares during 2010-11 as per the record of revenue department of the Govt. of H.P. Major forest produce available in the district are Timber and Charcoal. Beside major forest produce, there are also minor forest produce like resin, grass, medicinal herbs, bamboo etc. in the district. The major medicinal herbs found in the district are Dhoop, Kaur, Kuth, Guchhie, Kakar Singi, Bhojpatra etc.

1.5 Administrative set up.

Administratively the district has been divided into 7 sub divisions, viz. Shimla Urban, Shimla Rural, Theog, Rampur, Chopal, Rohru and Dodra Kwar. There are 12 Tehsils, 5 Sub Tehsils and 10 Community Development Blocks in the district. There are 363 village Panchayats and 2520 inhabited villages in the district.

3.5 Major Exportable Item

There is no major exportable items in district Shimla as the district is industrially underdeveloped.

3.6 Growth Trend

Owing to the severe topographical conditions prevailing in the district, there is negligible Large and Medium scale enterprises in the district. However, steady growth has been witnessed by the Micro and Small Enterprises in the district over years. From the table on year wise trend of registered units in the district it is evident that the district has witnessed per year registration of new micro and small enterprises ranging from the lowest registered units of 156 in 1989-90 to the highest registered units of 333 units in 2006-07. As far as the type of industrial units that have come up in the district is concerned, it can be seen from the table given at 3.3 above that the largest number of units in this district are of Repair and Servicing where 900 units have been registered. These units include units of auto repair, repair of electrical appliances, computer repair

etc. set up in semi urban and urban area throughout the district. Agro based group is the second group where 804 units have been registered. These units include small units like Atta Chakki, Oil Expeller etc. set up in villages also. Another group where significant number of units have been registered are the Metal Based group and Wood/Wooden Furniture group where 435 and 350 units have been registered respectively. As far as other industries in the district are concerned, it is evident from the table on Industrial Areas (I.A.) that only I.A. Shoghi has 36 units in production and rest of the three I.A are almost non existent. This is only due to the locational disadvantage of the district.

3.7 Vendorisation / Ancillarisation of the Industry

There is very little scope for vendorisation/ancillarisation as there is negligible large/Public sector undertakings in the district.

3.8. Medium Scale Enterprises

There is no medium scale enterprise in the district

3.8.1. Major Exportable Item

There is no major exportable items in the district as there is no medium scale unit in the district.

3.9 Service Enterprises

Since the industrialization has not taken deep roots in Shimla district owing to the topographical constraints, hence small service enterprises have come up almost in all parts of the districts. This is evident from the figure given in the table on MSMEs in the district wherein 900 Repairing & Servicing enterprises have been shown in the district registered with the DIC. Major service enterprises registered in the district are Atta Chakki, Oil Expeller, Auto Repair, Electrical Appliances Repair, Colour Lab, Data Procesing, PCO/Photostat etc. There is still good scope of setting up service enterprises in the district particularly on the line of huge tourism potential available in the district provided proper awareness is created among the educated unemployed youths and facilities in the form of infrastructure etc. is provided.

There is good scope of setting up of service enterprises in district Shimla as this district is the third largest district as far as population is concerned. Further, large number of tourists visit this district every year as the district is endowed with many tourist places, historical temples and age old fairs and festivals. These tourists create opportunity for servicing enterprises in the district. These service enterprises can be established in Shimla city and in almost all the Tehsil headquarters which are small towns. Based on

Present status of the cluster:-

Diagnostic Study for the Furniture and Fabrication cluster has been got prepared by the Industries Department of H.P. The proposal for soft intervention has been approved by the Steering Committee. The state Industries Department has been assigned to find out the fund receiving and implementing agency for conducting soft intervention.

5. General issues raised by industry association during the course of meeting

During meeting with the representatives of the Shoghi Industries Association, which is the only Industries Association in Shimla district, the foolowing issues were raised by the this association.

1. Improvement of Road

Existing road is in a bad shape because of the hill terrain the metal road does not last for long time .it is suggested the special budget may be allocated to construct this road with RCC.

2. Medical Facility

There is no medical facility available in the Industrial Area Shoghi. There is urgent need to have at least one Dispensary in the Industrial Area.

3. AB cabling for Electric Supply

Due to open valley normally the LT and HT wires get short circuited. It is required to be replaced with AB cable.

4. Staff Hostel

There is no provision for staff hostel. It is recommended that the staff hostel should be constructed in IA.

5 Tool room Facility

There is no tool room facility in district Shimla it is suggested that tool room should be established in this area.

6. **STP Plant**

There is old system of septic Tanks for discharge of sewage. There is a great need to install STP Plant.

7. Water Scheme

The existing water scheme is required to be strengthening by installing of water lifting pumps and replacement of old supply pines.
