**OFFICE ORDER**

In supersession of earlier Office Order No. A-22012/1/2015-A(P&T)(Vol-II) dated 28.08.2019, following changes in the said orders is hereby ordered with immediate effect:-

- (vii) In addition to his current charges/responsibilities, the works related to '**Credit Guarantee Scheme for MSMEs**' appearing at D08 may be read as allocated to Shri Deepak Rao, JDC. For the said charges/responsibilities, Shri Deepak Rao, JDC will report to Shri Piyush Srivastava, ADC.
- (viii) In addition to his current charges/responsibilities, the works related to '**SENET Scheme**' and '**Social Enterprise Development**' appearing at D03 & D04 respectively may be read as allocated to Shri G. Shanmuganathan, AIA. For the said charges/responsibilities, Shri G. Shanmuganathan, AIA will report to Shri D.P. Srivastava, DDG.


