MINUTES OF THE MEETING REGARDING IMPLEMENTATION OF GOODS & SERVICES TAX (GST)

UNDER THE CHAIRMANSHIP OF SECRETARY (MSME) DATE: 7th June, 2017

- 2. At the outset, Secretary spoke regarding speech made by the Hon'ble Prime Minister in the informal meeting held with Secretaries and letter received from Cabinet Secretary, which requires every Ministry/Department to create a GST facilitation cell that will work till 15th August, 2017 unless there are further orders to extend it further. He emphasized that the proposed cell will work as a problem solving cell with the problems addressed to it by various stakeholders being construed as the problems of that Ministry/Department.
- 3. It was desired that Development Commissioner (Micro, Small and Medium Enterprises) would be the overall in charge of the whole work regarding GST as he was earlier also chairing meetings regarding GST.
- 4. Secretary (MSME) desired that two officials Smt. Nivedita Gupta, DDG and Sh. Samar Nanda, Director will act as the nodal officers at the Ministry level; however, the O/o DC (MSME) will create the facilitation cell under the Chairmanship of one of the Additional Development Commissioners whose personal particulars e.g. designation, mobile number and e-mail address will be put in public domain through requisite

advertisement. The creation of the cell will be conveyed to all the major MSME Associations vide letters and a meeting of the senior officers of the Ministry will soon be convened with all the major Associations. This will also be conveyed to all MSME-DIs at a meeting which is to be held on 15th June, 2017 at office of Development Commissioner.

- 5. It was also agreed that Training Programmes will be organized by NIMSME to train both officials and various stakeholders like the individual MSME units. For this purpose, clusters can be identified and the name of the enterprise trained will be uploaded in the website of the proposed cell alongwith photographs and mobile number. There will also be GST Help Desks opened at 15 important MSME canters under the leadership of MSME-DI. AS&DC will ensure that Camps are organized in the major MSME Cluster in the next 15 to 20 days.
- 6. The various MSME DIs should also be apprised that National Institute for Micro, Small and Medium Enterprises (NI-MSME) is available for giving trainings on GST and 50-100 such training programme should be organized in the next 10-15 days. Wherever need be, CAs can be involved for training on the issue.
- 7. It was suggested that a separate GST Cell will also be opened as part of the Micro, Small & Medium Enterprises Internet Grievance Monitoring System (MSMEIGMS) so that GST complaints can be attended to and replied.
- 8. It was also decided that AS&DC will organize workshops at Delhi on GST immediately for the benefit of the officials and key stakeholders.
